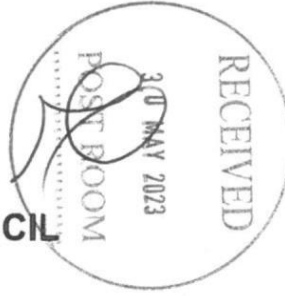

GENERAL NOTICE OF REGISTERABLE INTERESTS

I, IAN BACHELOR

Being an elected Member/Co-opted Member of HALBERTON Town/Parish Council,

Give notice in this form of those interests which I am required to declare under The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 and the Council's Code of Conduct:

I understand that in so doing I must declare any interest of my spouse or civil partner or of any person with whom I am living as a husband or wife or if we were civil partners in sections 1-6 of this form as set out in the Town/Parish Council's Code of Conduct for Members. I have also declared my personal interests as required by the Code of Conduct in section 7 of this form.

This document will be scanned and published on the website as a public document. The original paper copy will be filed and kept in a locked cupboard but made available to the public on request. The document will be retained for life of the Council (4 years) or the date of your resignation if earlier. Thereafter they are destroyed securely.
