GENERAL NOTICE OF REGISTERABLE INTERESTS


2. Sponsorship

3. Securities: Interests in Companies



5. Landholdings and Licences in the Area

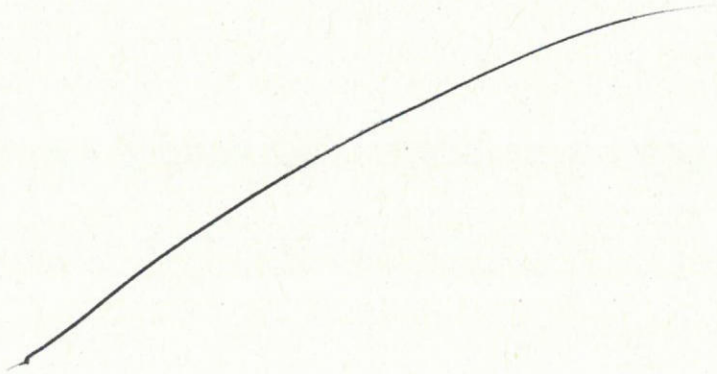

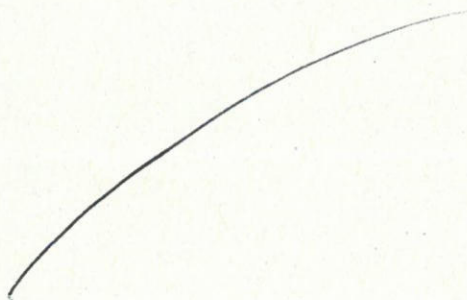

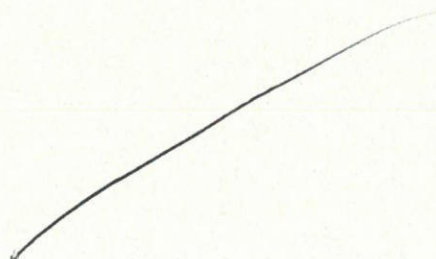
