Explanatory notes on relief for Charites and other 'not for profit' Organisations

The Local Government Finance Act 1988 provides for giving relief to charities and other similar organisations. These provisions fall into two categories.

1. Mandatory Relief

This relates to a registered charity or trustees for a charity.

Where a property is **occupied** by a charity or trustees for a charity, and is used wholly or mainly for charitable purposes (whether of that charity or of another charities) the charge is to be 20% or the normal rates payable.

Unoccupied property liability provides that where the ratepayer is a charity or trustees for a charity, and it appears that the intended next use of the property will be for charitable purposes (whether of that charity or of another charity), 100% exemption will be granted.

2. <u>Discretionary Relief</u>

- a) Additional discretionary relief of up to 20% can be granted to those institutions or organisations which received 80% mandatory relief as registered charities.
- b) Discretionary relief may also be granted up to 100%
 - 1. To certain bodies or organisations who are not conducted for profit **and** whose main objects are charitable or are otherwise philanthropic, religious, concerned with education, social welfare, science, literature or the fine arts:
 - 2. Where the property is wholly or mainly used for the purposes of recreation **and** all or part of it is occupied for the purposes of a club, society or other organisation not established nor conducted for profit.
