Please see below the Parish Council's comments on Mid-Devon District Council's Reg 16 response:

Conformity with Local Plan

One of our intentions for this Plan is that it will provide an inclusive and coherent reference for local people and organisations to take a creative interest in the future of Willand. It would undermine this if we could not include things important to residents because they overlap the Local Plan. We also wished to identify the importance of the areas mentioned in the event of a Local Plan review.

Replacement of facilities or assets within the Plan area

Willand is a discrete settlement with a strong and separate identity. The proposed Plan is constrained by the fact that the parish boundary is very tight to the settlement. MDDC has refused a proposal by our local District Councillors to rationalise the boundary and include a discrete area to the north which would be suitable for village growth. This is in Halberton Parish which cannot access it except via Willand or around via Sampford Peverell. Discussion with Halberton on joint work to include this area did not meet with their agreement. This prevented us in the Plan making any proposal other than what we have said. The amendments suggested by MDDC would create the very real possibility that relocated social, employment or other assets or facilities would end up in a location no longer integral to Willand.
