I am looking at this policy and Map 6, and am assuming that the areas of local biodiversity value are those listed in clause 1 of the policy. Other corridors marked on the map are for the purposes of Clause 2, I also assume.

I am proposing that Clause 3 be clarified to refer to the areas defined in Clause 1, as the level of protection proposed in the policy does not seem proportionate to the smaller green corridors shown on Map 6 but not listed in Clause 1.
