# **Burlescombe Parish Council communications update**

11 September 2024

## Key communications activities that have taken place

1. Parish magazine – In the September issue of the Parish magazine, we shared an update that highlighted the removal of the fallen tree from the Old Railway Line, the works to the Westleigh playpark by MDDC and the new nets in the adjacent football field. We also communicated the appointments to the Grand Western Canal Joint Advisory Committee and Comms Officer, and shared the dates of the next meetings. The Editor also felt it would be good to include the full minutes of the 6 July meeting and so these were published also.

## 2. Facebook

Posts on Facebook since we were elected have covered:

- An update from our inaugural meeting and a link to the MDDC website and noticeboards for agendas and minutes.
- Information about the Grand Western Canal and Broadpath Landfill site consultations.
- Westleigh Playpark, ORL tree removal and football net updates.
- A brief update from our 5 August meeting, directions to the MDDC website for minutes and agendas, and a brief summary of recent activities.
- The date, location and agenda of our 28 August meeting.
- The discovery of potential giant hogweed on the ORL and subsequent assessment that it was not the dangerous plant. Residents were however reminded not to touch or pick plants in the area.
- The date, location and agenda of this 11 September meeting.
- A note that Councillor Eaves has been liaising with DCC about potholes and sharing the link through which residents can report an issue.

Posts so far have resulted in 241 reactions (all positive 'likes' and 'loves').

And comments, including:

"Very nice and informative post. Let's see if we can get people attending meetings and feeling involved in the upkeep of our parish."

"Fantastic work! Thanks for keeping everyone updated."

"This is all so encouraging! Keep it up we are all behind you!"

Plus positive responses to the new football nets.

People have also commented to bring things to our attention including:

- Some hedges that needed cutting back in Westleigh (work completed very swiftly, just not by us).
- That the MDDC website details needed updating, which has happened.
- Their view on the Broadpath consultation.

Our Burlescombe Parish Council Facebook page has now been created, and the following message posted on the page and pinned to the top for all visitors to see.

Welcome to our page, which we will use to communicate our activities as your parish council.

If you wish to be a part of this online community, you must agree to abide by this code of digital engagement, which is designed to keep everyone safe.

Rule 4: Posts should not spread false or unverified information.

Rule 5: For transparency reasons, users should not post anonymously.

If any of these rules are broken, page admins reserve the right to delete posts, block users and report content to the police if necessary.
