

Hi Michelle

Thanks for coming back to me on this with some updated comments. It would appear that there are just three points left to address, so I'll cover those off below rather than by updating the spreadsheet again which I think has served its purpose.

Point 1 – additional footway provision required

We have addressed your comment by updating the access design drawing to include a 2m wide footway along the eastern side of the access road, around the junction bellmouth before eventually connecting into the existing footway along the southern side of Post Hill. We would appreciate confirmation that this amendment meets DCC requirements.

Point 2 – physical barrier between right turn lanes required

We have considered this request and haven't been able to identify this requirement within DMRB – it should also be noted that the right turning traffic flow into Champion Way is forecast to be minimal. We are therefore currently unconvinced that the physical barrier is required or necessary, especially considering the examples below of similar existing junction layouts within Devon:

A375 / Seaton Road Junction – red coloured hatching provided (albeit it is a little faded!)

A386 / Chanters Rd / Alexandra Terrace (Bideford) – no physical barrier, and not even any hatching / road marking provided

In light of the examples above, we currently consider that a coloured hatch area of separation should be appropriate, and this is also reflected in our updated drawing attached. That aside, this feels to me like a detailed design matter that would usually be considered at the Section 278 stage. We would appreciate confirmation that either the hatching as now proposed is appropriate, or that this matter can be dealt with at s278 stage. This can be dealt with at S278 stage, but this was raised by DCC Road Safety Officer

Point 3 – Delivery of traffic calming phase 2 required

You haven't been able to share the referred scheme details with us, however we suspect that some of the design features already proposed within our design would feature. In any event, I think it is reasonable to expect that any development unlocked as a result of this access junction being delivered might need to contribute / deliver some off-site highway works as mitigation, however this would need to comply with the CIL 122 Tests in the usual manner. This matter would be discussed in more detail at the planning application stage and we trust this is also acceptable to DCC. The Scheme has not yet been approved, but once it has I would like Stage 2 to come as part of this application.

Summary

In light of the responses to date, and the extra information provided within this email, it would appear that there are no fundamental concerns surrounding the proposed access design. We would therefore be grateful if DCC can confirm their in-principle agreement to the junction form / location, subject to some further details needing to be provided as part of a Transport Assessment at the planning application stage. In principle this looks like it could be an alternative access for Area B, subject to a full Transport Assessment.

Please find attached the report from DCC Transport Planning Team.

Comments on the 01-SK-101 Rev A

The design does not show a footway for pedestrians on the southern side, whilst there is currently a footway, also it only shows a footway on one side of the carriageway entering the site which should be on both for a development of this size.

The stacking length appears to be very short only 22m, DMRB states the length should be 25m and as this development will include an employment larger vehicle should be accommodated for. The plan does not provide lane widths, we would require this information.

I also have concerns regarding the visibility for the junction, there is no reference the visibility splay that can be achieved.

Hi Michelle – I hope you are well....

As I think you already know, Mid Devon Homes have appointed us to look at potential options for providing access into Area B of the Tiverton Urban Extension from Post Hill. This has focussed on the area immediately south of the existing junction with the road leading up to the golf course, and the option we have drawn up is for a priority junction with ghost island right turn lanes. The Tech Note attached explains the design rationale underpinning that option, including selection of design parameters and initial capacity testing, and a drawing (1496-01-SK-101-A) showing the junction arrangement is included in Appendix A at the back of the report.

We'd be grateful if you could review the attached and come back to us with your thoughts on this approach. We appreciate that this is early days and that there would be a process of design refinement, road safety audit etc to go through in due course, but for the time being we are simply looking for a view on whether this approach is likely to be considered acceptable in principle by the highway authority.
